## **MEETING MINUTES**

## I. OPENING

#### A. Roll Call

- The meeting was called to order at 9:06 a.m. Law Enforcement Certification Board Operations Officer Laura Escarcida conducted roll call confirming the in-person attendance of members: Chief Erin Toadlena-Pablo, Chief Thomas Romero (ret.), Cody Roders Benavidez, Julie Ball, Dr. Bobbie Green. Board Members Joseph Walsh, and Carly Huffman attended virtually. Board Members Sheriff Adan Mendoza and Vice-Chair Chief Summer Mirabal were absent. A quorum was established.
- Member Cody Roders Benavidez moved to designate Member Chief Romero to chair the
  meeting as the vice-chair was absent and the chair position is vacant. Member Julie Ball
  seconded the motion.

## B. Approval of Agenda

- Member Cody Roders Benavidez moved to approve the agenda. Member Dr. Green seconded.
  Members Chief Erin Toadlena-Pablo, Chief Thomas Romero (ret.), Cody Roders Benavidez,
  Julie Ball, Dr. Bobbie Green, Joseph Walsh, and Carly Huffman voted in favor of the motion
  and none opposed, motion carried unanimously.
- C. Approval of Minutes from June 13, 2024, Meeting
  - Member Joseph Walsh moved to approve the minutes form the June 13, 2024 meeting. Member Julie Ball seconded. Members Chief Erin Toadlena-Pablo, Chief Thomas Romero (ret.), Cody Roders Benavidez, Julie Ball, Dr. Bobbie Green, Joseph Walsh, and Carly Huffman voted in favor of the motion and none opposed, motion carried unanimously.

#### II. REPORTS

- A. Report from Interim CEO / LEA Director Sonya K. Chavez
  - NMLEA Director Sonya K. Chavez provided a staffing update related to the Law Enforcement Certification Board Chief Executive Officer position and NMLEA internal positions and personnel changes. Information was relayed to Board members regarding the NMLEA BPOT class #208 and initiatives by the basic and advanced bureaus of the academy, as well as a legislative push for retirement changes effecting

commissioned law enforcement officers employed by the NMLEA. Director Chavez further advised the Board of the NMLEA's intent to move forward with satellite academy compliance audits. Member Ball inquired into status on the designation of office space for the LEC Office, how the LECB budget may be impacted due to staff vacancies, and retirement contribution percentage questions for commissioned staff. Chief Romero reflected on his experience working for the NMLEA and encouraged members to reach out to legislators to support changes to the retirement tier for commissioned staff.

#### IV. NEW BUSINESS

- A. Ratification and Approval of Pending Certifications

Member Ball inquired into whether Director Chavez or CEO Calder reviewed and verified that individuals met certification qualifications, Director Chavez confirmed. Member Joseph Walsh moved for approval of the ratification of pending certifications as listed in Exhibit A. Member Chief Toadlena-Pablo seconded. Members Chief Erin Toadlena-Pablo, Chief Thomas Romero (ret.), Cody Roders Benavidez, Julie Ball, Dr. Bobbie Green, Joseph Walsh, and Carly Huffman voted in favor of the motion and none opposed, motion carried unanimously.
  - 2) Public Safety Telecommunicators (Exhibit B)
  - Member Chief Thomas Romero (ret.) entertained a motion to approve the ratification of pending certifications as listed in Exhibit B. Member Ball inquired into whether Director Chavez or CEO Calder reviewed and verified that individuals met certification qualifications, Director Chavez confirmed. Member Carly Huffman moved for approval of the ratification of pending certifications as listed in Exhibit B. Member Cody Rogers Benavidez seconded. Members Chief Erin Toadlena-Pablo, Chief Thomas Romero (ret.), Cody Roders Benavidez, Julie Ball, Dr. Bobbie Green, Joseph Walsh, and Carly Huffman voted in favor of the motion and none opposed, motion carried unanimously.
- B. Discussion on Academy Application Processes and Improvements
  - Director Chavez called upon NMLEA Deputy Director Brian Coss to present on this
    item. DD Coss informed the Board that the NMLEA has shifted its academy
    application review process requiring satellite academies to provide the NMLEA with

complete academy application packets rather than sat-application packets previously required.

- C. Discussion on Compromised block tests/LEOCE tests
  - Director Chavez updated on the discovery of academy block tests and the LEOCE test being compromised for both law enforcement training and public safety telecommunicator training, efforts to rewrite tests, and investigation into test leak.
- D. Discussion of Legal Representation and possible action to retain legal representation
  - New Mexico Department of Justice, Director Blaine Moffatt, discussed his agency's
    position as legal counsel to public bodies and the Board's ability to seek alternative
    legal counsel as their own discretion if the Board is not satisfied with services.
  - Director Chavez discussed circumstances where the NMDOJ and the Department of Public Safety does not have the ability to provide general legal advice to Board contractors or members. Member Cody Rogers Benavidez made a motion to give the Director authority retain legal counsel for hearing officers at the Director/CEO's discretion. Member Joseph Walsh seconded. Members Chief Erin Toadlena-Pablo, Chief Thomas Romero (ret.), Cody Roders Benavidez, Julie Ball, Dr. Bobbie Green, Joseph Walsh, and Carly Huffman voted in favor of the motion, and none opposed, motion carried unanimously.
- E. Request for Exception to the Application Requirements under NMAC 10.29.10.10(B) by NM Department of Information Technology, Director Michael Rohrbacher
  - NM Department of Information Technology, Director Michael Rohrbacher presented on his agency's request for the Board to allow an exception under NMAC 10.29.10.10(B), as two employees have exceeded the one-year allowance to operate without a certification. Member Carly Huffman moved to accept request to allow exception. The motion was not seconded, and the motion died for lack of a second to the motion. No other action was taken on this item.
