MEETING MINUTES

I. OPENING

- A. Roll Call
 - The meeting was called to order at 9:28 a.m. Law Enforcement Certification Board Operations Officer Laura Escarcida conducted roll call confirming the in-person attendance of members: Chief Erin Toadlena-Pablo, Chief Thomas Romero (ret.), Vice-Chair Chief Summer Mirabal, Carly Huffman, Julie Ball, and Dr. Bobbie Green. Board Members Sheriff Adan Mendoza, Joseph Walsh and Cody R. Rogers were absent. A quorum was established.
- B. Approval of Agenda
 - Member Chief Thomas Romero (ret.) moved to approve the agenda. Member Julie Bell seconded. Members Chief Erin Toadlena-Pablo, Chief Thomas Romero (ret.), Vice-Chair Chief Summer Mirabal, Carly Huffman, Julie Ball, and Dr. Bobbie Green voted in favor of the motion, and none opposed, motion carried unanimously.
- C. Approval of Minutes from September 12, 2024, Meeting
 - Member Chief Erin Toadlena-Pablo moved to approve the minutes from the September 12, 2024, meeting. Member Chief Thomas Romero (ret.) seconded. Members Chief Erin Toadlena-Pablo, Chief Thomas Romero (ret.), Vice-Chair Chief Summer Mirabal, Carly Huffman, Julie Ball, and Dr. Bobbie Green voted in favor of the motion, and none opposed, motion carried unanimously.
- D. Welcome remarks made from Commander Joseph Viers, Albuquerque Police Department

II. REPORTS

- A. Report from Chief Executive Officer, Joshua M. Calder
 - LECB CEO Joshua M. Calder provided a staffing update related to the Law Enforcement Certification Board by onboarding Jackee Garcia as a Staff Manager and the resignation of a compliance officer, and efforts made with the intention of reclassifying the now vacant position. In the interim, the only compliance officer for the law enforcement certification office, Maria Lozoya-Grado has taken on all compliance officer duties. CEO Calder informed the Board he was working through the

Page 1 of 10 Law Enforcement Certification Board December 12, 2024, Meeting Minutes process to get Mrs. Lozoya-Grado a temporary salary increase, which was denied initially, but the office is still working through the administratively attached process, CEO Calder requested the Boards support. The staff attorney position was posted on the website and CEO Calder asked for referrals. With the hiring of Ms. Garcia all available offices have been filled. Until we get office space, we cannot begin to fill other positions. CEO Calder was in contact with Troy in September and asked that he expand the search for office space beyond Santa Fe to Albuquerque, which will open office options and candidate options. Member Julie Ball questioned the office space next to the LEA in Santa Fe. Operations Ms. Escarcida stated the building was an outside building that DPS was going to allow the use of, explained quotes were obtained to renovate, but DPS had a separate use for the building. At this time, it was initiated to look for leasing options and search is still ongoing. CEO Calder informed the members he did have a meeting with the DPS budget team on Monday; and it looks like from a meeting between DPS and the LFC, the budget is being asked to increase from \$961,000 to \$1.3 million. CEO Calder stated if he were to fill all twelve positions, that would heavenly burden the \$961,000. He did some research into when the separation of the Board happened, and it looks like there was \$2,075,600 for the use of certification board, the DPS budget team is currently looking into that. Ms. Ball asked about going forward with a separate budget due to being an independent state agency and provided the administrative support of DPS. CEO Calder was not sure if the budget can be manned by his staff, and this was the purpose of administratively attached. Member Julie Ball agreed but stated if they are telling us what our budget is, then they (DPS) have votes, and that is not the realm of this board, but it is something to keep in mind. The administrative support can still go forward and present our members and needs. Board Counsel Rebecca Guay offered to put together a presentation to clarify what administratively attached means. Member Julie Ball continued to ask one more question about the vacant positions, stating only one position has been posted, and asked if waiting on office space was the reason for the wait. CEO Calder confirmed and mentioned to the board the Staff Attorney position was posted for Santa Fe and Albuquerque depending on where office space is found. Member Julie Ball confirmed the six vacant positions would be holding off on posting. CEO Calder confirmed and will be posting those positions once we get an idea on space.

CEO Calder informed the board a meeting with a company called the BOX is scheduled for the following week and will be used as our data management system and set to go live next week. The program will provide work on case files, have workflows, and information sharing. Summary from last board meeting, the database for misconduct reporting is operational. Purchased the Owl system and will be used going forward with meetings. Misconduct reporting for this calendar year has increased 41%. Member Julie Ball stated she checked out the misconduct website and notices 2022-present have been uploaded and asked if there was a plan to submit the past cases. CEO Calder confirmed yes, and Ms. Escarcida stated with acquiring the BOX we intend to digitize the historical records and once staff is gained there will be one or two designated to help update the misconduct database.

The Board agreed to hold the 2025 Board meetings in either Santa Fe or Albuquerque and to readdress the topic in December 2025 for meeting locations in 2026; and to hold the meetings on the dates provided.
